5. President's Report

The President thanked members for their ongoing support and commitment to the Society.

She mentioned the impact on Covid on the Society's activities, resulting in a mix of face-to-face and online events and meetings during the year.

Online events included:

- Ongoing Zoom culture series, with speakers on wagashi making, netsuke, and New Year ikebana
- Olympics trivia event in conjunction with JETAA (JET Alumni Association)
- Fireside chat with member Peter Gibson, going behind the scenes at the Olympics/Paralympics
- Author Libby Hathorn and illustrator Sadami Konchi talked about their children's book based on Basho's travels
- Member Chris Gallagher presented on his career as an English teaching specialist in Japan

The in-person events included the:

- New Members' Welcome event in March
- Bushwalk around the Manly Quarantine Station

Other in-person events included:

- Japanese-speaking evening Shaberanaito, a joint event with JETAA
- Former diplomat John Langtry spoke about the Australia-Japan security partnership in the regional context, and
- The annual signature event, the Student Awards Evening, held in May, which this year was expanded to include the University of Newcastle.

The President extended the appreciation of the Board to Consul-General Kiya Masahiko and thanked the Consul-General and his staff for their ongoing support. She also thanked the aligned organisations including the Japan Foundation, CLAIR, JCCI, JETAA and KPMG for their support throughout the year.

The President indicated membership remained strong and thanked members for their support throughout the year and for their participation in the events and activities throughout the year.

She thanked all Board members for providing their time voluntarily and for their individual contributions throughout the year.
